Robotti BD charges commissions to execute trades. In addition to the commission charges you pay for transactions you may incur incidental fees charged by Robotti BD or our clearing broker-dealer, Pershing LLC, where your securities are custodied. These fees may include custodial,

maintenance and transfer fees. Robotti does not offer any proprietary products nor do we recommend a limited menu of investment products.

When we provide you with a recommendation, we must act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the recommendations we provide you. Because broker-dealers make money on each trade some may encourage investors to trade often. Robotti BD takes every step possible to obtain the best price and timing when placing your trades.

Additional Information: You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.
